

Old Republic Announces Regular Second Quarter Dividend of 17.25 Cents

CHICAGO, May 13, 2010 /PRNewswire via COMTEX/ --The Board of Directors of Old Republic International Corporation (NYSE: ORI) today declared a quarterly cash dividend on the common stock of 17.25 cents per share. This dividend is payable June 15, 2010, to shareholders of record on June 4, 2010. Subject to quarterly board approval of each quarter's new rate, the full year's cash dividend will amount to 69 cents per share compared to 68 cents paid in 2009.

This latest dividend increase marks the twenty-ninth consecutive year that Old Republic has boosted its cash dividend rate; 2010 marks the 69th year of uninterrupted cash dividend payments.
